- 1.1.  - 1.2. The basic participation fee excludes visa fees, airfares, travel insurance, hotel accommodation, local transportation, meals and customs clearance. Those and any likely expenses have to be borne by the participant in addition to the basic participation fee.
 - 1.3. Travel and Accommodation: To be organised by each Partner/Operator individually.
 - 1.4. The participation fee for all 4 cities: EUR 3.100. This is a full package for the whole Roadshow. No booking of single cities is possible
