All other table setups shall be arranged by the participants; accordingly, attendees are advised to bring along their brochures, flyers, business cards, and laptops for presentation purposes.*
- 2.2 *The basic participation fee does not include visa fees, airfares, travel insurance, hotel accommodation, local transportation, meals, customs clearance fees, or Osaka Expo tickets. These expenses, along with any other potential costs, must be borne by the participant in addition to the basic participation fee.*
- 2.3 *Marketing agents/companies or Destination Management Companies (DMCs/DMOs) that represent a range of individual accommodation establishments or regulated businesses not belonging to the same group are required to pay the participation fee plus a 20% surcharge. This rule also applies to any other business operators not legally required to register with NTB Associations.*
- 2.4 *For each company, the third and subsequent representatives will be charged an additional 10% of the participation fee per person.*
