- 1.1 NTB trade fair policy dictates that only one company is allowed per table.
- 1.2 Where only one company occupies a table, and they want a second or any additional representative from the same company, will pay the basic participation fee plus a surcharge of 10% for such an additional representative.
- 1.3 Marketing agents/companies or Destination Management Companies (DMCs/DMOs), who represent a whole range of individual accommodation establishments or regulated businesses, not belonging to the same group, must pay the participation fee plus a surcharge of 20%. The same principle is applicable to any other business operator not required by law to register with NTB and Associations.
- 1.4 The basic participation fee excludes airfares, travel insurance, hotel accommodation, local transportation, meals, and customs clearance. Those and any likely travel expenses must be borne by the participant in addition to the basic participation fee.
- 1.5 The basic participation fee includes a branded table, chairs, one power outlet, and access badges. Table setups and other branding will be done by the participants; therefore, you are encouraged to take along your brochures/flyers, business cards, and laptops for presentation purposes.
- 1.6 Due to limited funding for NTB, no <u>SME support</u> for participation at these events will be done in terms of the NTB SME Policy.
